

TAX LEVY ORDINANCE

ORIGINAL

TOWNSHIP

ORDINANCE No. 20-03

An ordinance levying taxes for all town purposes for Elgin Township,  
Kane County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Elgin Township,  
Kane County, Illinois, as follows:

SECTION 1: That the sum of Two Million Four Hundred Thirty Thousand  
Nine Hundred and Ninety Five Dollars & 00/100 (\$ 2,430,995.00) are hereby levied upon all  
property subject to taxation within the Township as that property is assessed and equalized, in order to  
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted  
by the people in accordance with the law, for such purposes as:

for the year 2021.


SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Elgin Township Road District.



**ELGIN TOWNSHIP RESOLUTION NO. 20-01**


WHEREAS, the voters in Elgin Township passed the following referendum at the March 17, 2020 primary election:






