Road Comments, Road commissioner Seyller received the paving invoice. The new truck came in. Commissioner Seyller still needs to break up the salt for winter.

2. Social Service Funding Presentations. Presentations were made by Northern Illinois Food Bank, Crisis Center, Ecker Center, PADS, Family Service Assoc of Greater Elgin Area, Renz Center, Fit for Kids, Administer Justice, Fox Valley Hands of Hope, Food For Greater Elgin, Greater Elgin Family Care Center, Centro de Informacion, Summit School, Inc., Elgin Cooperative Ministries, AID, Literacy Connection, Corbella Clinic, Boys & Girls Club, Elgin Partnership for Early

Learning, Senior Services, YWCA, do-over.me, Easter Seals, United way.

3. Award funding; After presentations the board held a discussion regarding taking money out of Levy for Senior Services. Upon more discussion, money is to be taken out of Social Service funding instead of Levy. This year's resources of \$376,500.00 will be allocated to the following agencies; Administer Justice \$5,000, AID \$35,000, Boys & Girls Club \$15,000, Centro de Informacion \$24,500, Crisis Center \$55,000, Corbella Clinic 0, do.over.me 0, Easter Seals \$10,000, Ecker Center \$55,000, Elgin Coop. Ministry \$10,000, Elgin Partnership for Early Learning \$4,000, Family Service Assoc..of Greater Elgin \$20,000, Fit for Kids \$5,000, Food for Greater Elgin \$28,000, Fox Valley Hands of Hope 0, Greater Elgin Family Care Center \$35,000, Literacy Connection \$10,000, Northern IL Food Bank \$15,000, PADS \$30,000, Renz Center \$10,000, Senior Services \$45,000, Summit School Inc. 0, United Way 0, YWCA \$10,000. Supervisor Ramirez made a motion to Award the Agencies as read. Motion seconded by Trustee Van Weelden. Discussion held. Ayes; Supervisor Ramirez, Trustee Van Weelden, Trustee Villalobos, Trustee Tepe, Trustee Guerra. Nay's; 0. Motion carried 5-0-0.
