On March 9, 2020 in light of the circumstances surrounding the public health emergency caused by Covid-19, Governor Pritzker issued a Disaster Proclamation for the state of Illinois. He renewed this proclamation on April 30, 2020 and it is still in effect. On March 16, 2020, Governor Pritzker issued Executive order 2020-07, which suspends for the duration of the Gubernatorial Disaster Proclamation, certain provisions of the Illinois Open Meetings Act. Specifically, the order suspends the in-person attendance by members of a public body and suspends the conditions limiting when remote participation is permitted for attendance at a public meeting. That Executive order was also renewed by Executive order 2020-33, signed on April 30, 2020. Therefore, pursuant to Executive Order 2020-07 and 2020-33, a member of the Township board is attending this June 8, 2020 General Town Public hearing by means other than physical presence is doing so lawfully. Such member is participating by video conference. The rest of the Township board met downstairs in meeting room A at the Township building. The meeting was called to order by Clerk Karen Dowling at 5:30 pm. The Pledge of Allegiance was led by Clerk Dowling.
