The regular meeting of the Town of Elgin, Illinois was held in Board room. The meeting was called to order by Supervisor Ken Bruderle at 6:00 p.m. Clerk Dowling led the Pledge of Allegiance.

B. APPROVAL OF MEETING MINUTES

A motion was made by Trustee Stare to approve the minutes of the July 11, 2022, regular Township Board meeting. Seconded by Trustee Bialek. Motion carried 5-0-0.

C. REPORTS

- 1. Assessor Comments; Assessor's office; Still waiting for certification for Kane County supervisor of assessments. Once certified, we will list the dates of the 30 day appeal period on our website. We continue to process property sales, new construction & permits for residential & commercial properties.
- 2. Road Comment's; Local 150 strike has ended & Geneva Construction will be resuming paving operations. They have informed township they haven't forgotten about us and will contact us in the coming weeks to start paving. Preform Traffic Control Systems finished striping our lines. We started our 3rd mowing of the season. Coombs Bridge project has started. The deck has been removed, new piles are being driven in, & abutment work has started. We are moving forward with replacing truck #3 (2010 International). It is still projected to be 2 years out. Waiting for new state bids to come out to look into replacing truck #1 a 2013 F150. As always, continuing with daily activities; battery collection, tree trimming, shouldering, drain cleaning & road repair as needed.

6. Committee on Seniors Report- Trustee Janet Rogalla; The new application is almost finalized & Trustee Rogalla would like to have our Attorney Mark Schuster look it over. The new time & date for the meetings is the 4th Thursday of every month at 7 pm. The committee decided not to have a mission statement. Trustee Rogalla attended the TRIAD picnic.

- 2. Appointment of Members of Committee on Seniors (including specific terms of office); Carl Strathmann is up for re-appointment in August. Joann Hartman has declined to be re-appointed to the committee. Trustee Bialek made a motion to re-appoint Carl Strathmann. Seconded by Trustee Lopez. Discussion held. Roll call vote; Trustee's Lopez, Bialek, Rogalla, Supervisor Bruderle. Nays; Trustee Stare. Motion carried 4-1-0. Supervisor Bruderle made a motion to appoint Marianne Rowe for a 3 year term to replace Joann Hartman. Seconded by Trustee Stare. Discussion held. Roll call vote; Ayes, Trustee's Lopez, Bialek, Stare, Rogalla, Supervisor Bruderle. Nays; None. Motion carried 5-0-0.

Trustee Stare made a motion to recess at 6:32 pm. Supervisor Bruderle called the meeting back to order at 6:34 pm.

Supervisor Bruderle made a motion to approve Alfredo Ramirez for a 1 year term to fill Rod Ash's term. Seconded by Trustee Stare. Roll call vote; Ayes, Trustee's Lopez, Bialek, Stare, Rogalla, Supervisor Bruderle. Nays; None. Motion carried 5-0-0. Supervisor Bruderle made a motion to appoint William Lucas for a 2 year term to fill Jim Fox's term. Seconded by Trustee Lopez. Discussion held. Roll call vote; Trustee's Lopez, Bialek, Stare, Rogalla, Supervisor Bruderle. Nays; None. Motion carried 5-0-0. More discussion held.

H. TRUSTEE COMMENTS

Trustee Lopez asked if Trustee Rogalla could be voted in as Chairperson on the Senior committee, to become a voting member versus being the board liaison. Discussion held. If appointed, Trustee Rogalla would be happy to step up if needed.

I. SUPERVISOR'S COMMENTS

Supervisor Bruderle would like the new 708 Board to have an informational meeting & to meet each other in a few weeks. INC Board NFP is the administrators of 7 of 708 Boards in Kane County. Supervisor Bruderle may invite an administrator to the meeting. Supervisor Bruderle was invited to attend a mental health board symposium on Sept 24th. The senior utility assistance program had 116 total applications. A lottery was performed & 57 applicants were sent letters approving them. The totals to the utility companies are ComEd \$15,198, Nicor \$3,250 & City of Elgin \$1,502. There has been a spike in the number of residents obtaining their senior access pass. We have distributed COVID test kits & hand sanitizer to residents. Greater Family Health picked up Covid test kits. Flu & shingles vaccine clinic is coming up & will be posted on Facebook page. Have had demand for pet food from Seniors & we appreciate the generosity residents have shown. Township-area service agencies and service clubs will be at the August 20th "What Makes Elgin Township Tick?" event. The staff will start working on the next newsletter that will be mailed to all households within the Township in early August. "What Makes Elgin Township Tick?" event will be promoted, as well as services offered by the Supervisors office, Assessor and Road district.
