## **A. APPROVAL OF MEETING MINUTES**

A motion was made by Trustee Rogalla to approve the Regular Town Board meeting minutes of January 13, 2024. Motion seconded by Trustee Bialek. Motion carried 3-0-0.

#### **B. REPORTS**

- 1. Assessor Comments- Assessor Surnicki: In Assessor Surnicki's absence, Clerk Dowling read his report: Continuing to process sales of properties, permits, and assisting seniors. Our review of all 2025 assessments has begun and will end in the first part of June.
- 2. Road Comments- Commissioner Krabbe: There have been 7 plowing/salting events since the last meeting. Curran Contracting Company won the bid to resurface Hidden Hill subdivision. They were 18% under the engineers' estimate. Working with the city of Elgin on resurfacing Nolan Rd., Weldwood Dr., Flagpole Ct., and Leith Ct. Received our first salt order of 200 tons.
- 3. Kane County Sheriff Dept Representative- Deputy Santiago Hernandez reported we are expecting snow on Wednesday so slow down and drive safely. Don't leave vehicles unattended while running. There have been thefts of vehicles, but none in Elgin Township.
